俄罗斯通信设备FAC认证合格评定是国家监督的强制性程序之一。可以通过联邦通信局(FAC)合格证书或FAC符合性声明,来证明该产品符合通讯技术要求。只有在获得通讯设备FAC证书之后,通信设备才能投放到俄罗斯联邦市场。FAC证书的有效期通常为1到3年。但是FAC符合性声明的有效性不受限制无限期。The conformity assessment of communications equipment is a compulsory procedure of state supervision. The compliance with technical requirements can be proved either with the Federal Communications Agency(FAC)Certificate or FAC Declaration. Only after that communications equipment can be placed on the market of the Russian Federation. A FAC certificate is generally valid between 1 and 3 years. The validity of a FAC declaration, however, is unlimited.

If communications equipment cannot be connected to the public switched telephone network it does not need any

conformity approval from the Federal Communications Agency. Anyway, the equipment can subject to technical regulation of the Eurasian Economic Union. If the equipment could be used for the encryption of data it is subject to the notification by the Federal Security Service of the Russian Federation (FSB).
