国际拍卖申请注册对注册资本有哪些规定？

一般的国际拍卖申请注册只需有一百万RMB以上的注册资本，珍贵文物国际拍卖的注册资本略高，要有一千万以上的注册资金+尽管无需认缴出资额，可是全国各地每一个地域的交纳状况都是有详细的规定，提议在宣布申请注册国际拍卖以前先掌握清晰。

What provisions does international auction application registration have to registered capital?

The general application for the registration of the international auction should only have the registered capital of more than 1 million RMB, the registered capital of the international auction of the precious cultural relics is slightly higher, and the registered capital of more than 10 million. Although there is no need to subscribe, the contribution status of every region across the country is detailed, and it is proposed to be clear before announcing the application for registration for an international auction.

申请注册一家国际拍卖有没有什么实际的规定？

也有许多细细的的规定，包含对国际拍卖的规章有规定，一定要达到全新修定的竞拍管理条例，要有与竞拍业务流程相符合的机器设备，要有一年以上租期的经营地，自然已有场所更强，那样审批的困难会有些减少。。

Is there any practical regulations for applying for registration for an international auction?

There are also many careful provisions, including the rules of international auction regulations, must achieve the new

revised auction management regulations, to have machinery and equipment consistent with the bidding business process, to have more than a year lease period of business, naturally stronger, the difficulty of approval will be somewhat reduced.

The above is a relatively simple international auction application standard for registration. It is proposed that before announcing the application for registration, it is best to analyze the local policies and regulations clearly first, so that it is impossible to be too confused about how to register the auction company. The following people will mainly talk about the bidding company registration process.
