This program is managed by the United States Customs and Border Protection Agency and aims to protect the security of goods entering US territory while promoting trade flows into and out of the country. The revalidation was released after extensive security audits by C-TPAT supply chain security experts at DHLGlobal Forwarding (DGF) facilities in the Americas. Each visit includes a detailed inspection of DGF supply chain security, a comprehensive review of all relevant DGF policies and procedures, and an extensive review of warehouse operations.

At DHL Global Forwarding, compliance with C-TPAT and all other global security plans is crucial for the way we conduct business, "said Bill Meahl, CEO of DHLGlobal Forwarding Americas. The re validation reaffirms our continuous commitment to supply chain security and consolidates our supply chain security tradition. In addition, C-TPAT supply chain security experts have awarded DGF 11 practices in the field of supply chain security risks, including personal security, security training and threat awareness, information technology security, and business partner requirements; Containers, transportation vehicles, and transportation safety; Program security; And personnel safety. The re validation of is expected to be implemented for four years, strengthening the company's understanding of supply chain security, which is the cornerstone of its Americas supply chain security consulting service (launched in 2017).
