领事认证的概念

领事认证 (LEGALIZATION BY EMBASSY OR CONSULATE)，又称“使领馆认证”。从广义上来说，领事认证是指由外交、领事机构证明申请人所提交的文件上一个签字或印章属实，从而使该文件具有境外使用的法律效力。

Concept of consular certification

LEGALIZATION BY EMBASSY OR CONSULATE, also known as "Embassy and Consulate Certification". Broadly speaking, consular certification means that the diplomatic and consular institutions prove that the last signature or seal on the document submitted by the applicant is true, so that the document has the legal effect of use in the situation.

领事认证的费用

一般情况下，办-理领事认证所发生的费用由我司先行垫付，待认证文件寄回，再据实结算。对于有不良记录（结算不及时等）的合作伙伴，则应预交办-理费用。

1. Under normal circumstances, the expenses incurred in the certification of consul-to-consul will be paid in advance by our company, and will be settled after the certification documents are returned. For partners who have bad records (not timely settlement, etc.), they should pay in advance-manage fees.

2. 已送进使领馆进行认证的文件或单据，申请单位发现错误要求退回的，须提供盖有单位公章的书面撤单申请，贸促会可以帮助及时追回，但其已发生的费用，申请单位必须承担。

Documents or documents that have been sent to the embassy or consulate for certification. If the applicant finds an error and requests for a return, it must provide a written application for cancellation of the order with the official seal of the unit. The CCPIT can help recover it in time. bear.

3. 由于各个country使领馆的规定、收费及注意事项时有调整，所以办-理领事认证的费用不是一成不变的。

Since the regulations, charges and precautions of various country embassies and consulates are adjusted from time to time, the cost of certification for consulates and consulates is not static.

不予认证的规定.

领事认证是外交或领事机构以country名义进行文书推介和确认的活动。因此，当您的文书中有违反我国及文书使用国法律法规，损害我国主权和尊严及社会公共利益等内容时，认证机*关有权不予认证。同时，涉外公证/书、相关证明、单据等不符合《公证法》及《公证程序规则》等有关规定时不予认证。关于领事认证的相关解释权归外交部所有。
