From September 2007, according to the new CCPIT regulations, CCPIT endorsement documents cannot be directly endorsed on the documents. They must be endorsed in the form of a certificate.

Can foreign-related notarizations/documents or other documents issued by the notary office (province, city) of Province A (City, City) be signed at the foreign consular office in Province B (District, City)?

Answer: No. Since the provincial foreign affairs office entrusted by the Ministry of Foreign Affairs with the signing of the consul-general only holds the signatures or seals of the foreign notary offices or other certification agencies in the province, district and city, it is inconvenient to verify the authenticity of documents issued by other provinces and cannot Do it for you-just sign it. Therefore, the parties should go to the foreign-related notary office or other organization where the hukou, residence or relevant facts occurred to apply for an office certificate/document or other document, and apply for the consular endorsement at the provincial foreign office to which the notary office or other organization belongs.

办-理领事盖章（领事馆盖章）的小贴士

贴士一：

不光是公证/书要办-理领事盖章，商业文书也要办-理领事盖章，如贸促机构、检验检疫等机构出具的各

类文书，多数也需办-理领事盖章后，才能在国外正常使用。

贴士二：

申办领事盖章分三步走：步要办好各种材料的公证/书或商业文书，第二步要拿着办好的文书申办外交部的领事盖章，第三步送至驻华领事馆的领事盖章，缺一不可。

贴士三：

企业出口所涉及的文件哪些需办-理领事盖章要根据文书接受国的要求，有的country这次不需要，下次也许需要。企业一定要弄清楚对方country是否要求办-理领事盖章，要办哪些文书的领事盖章。

贴士四：

出口country不同，盖章规定不同。各国对所盖章的文书均有自己的规定，企业在办-理公证/书或其他商业证明书之前要弄清楚规定，避免因不符合要求被退件。如有不明白之处还可以拨打咨询TEL：15913941040

贴士五：

申办领事盖章要提前准备，尽早申请，因为大部分country驻华领事馆需要一定时间办-理领事盖章，且没有加急业务。时间就是金钱，企业一定要提前了解接受国(单位)的有关要求，尽早申办相关文书的领事盖章。
