商业类文件是涉及公司业务的内容，主要有：

(1) 用于通关结汇的各类商业文件，如：原产地证、商业Invoice、装箱单、提单、商检证、屠宰证、船证明、保险单等；

(2) 用于涉外商贸活动的各类证明文件，如：合同、报关单、授权书、代理协议、营业执照、资信证明、投标文件等

(3) 其它与涉外商贸活动相关需办-理领事认证的文件。

商业文件认证流程：商业文件有些要做成商事证明书的形式，有些可以做成公证/书，然后送代理处递交外交部和使馆认证。

商会认证至少分两种：产地证商会认证，这时可以在产地证第5栏加盖个商会章。文件商会认证，就是要做成商事证明书的形式了。使馆认证的含义：近年来，随着经济全球化的发展，我国向中东，拉美，非洲等国这和地区的出口贸易是益增长，大量物美价廉的商品大量占入了这些country的市场，给他们本国的企业造成的冲击，因此这些country为了保护本国企业的利益和市场，纷纷制定贸易保护措施和产品政策，要求我国出口的货物的有关单据必须经过其驻华使馆的认证，方可办-理进口该国的通关手续。常见的有阿根廷和埃及，该国就明确规定，凡是我国出口到该国的货物，必须出具一般原产地证明书，并由

其驻华使馆审核后，在证/书背面加盖印章，对证/书加以确认，该批货物方能顺利通关。这种在有效单证上由驻华使馆盖章认证的做法，就叫“使馆认证”！

There are at least two types of chamber of commerce certification: the certificate of origin certificate of the chamber of commerce. At this time, you can affix a chamber of commerce stamp in the fifth column of the certificate of origin. The certification of the document chamber of commerce is to form a commercial certificate. The meaning of embassy certification: In recent years, with the development of economic globalization, China ' s export trade to the Middle East, Latin America, Africa and other countries and regions has increased, and a large number of high-quality and low-cost commodities have occupied these country markets. In order to protect their domestic enterprises, these countries have formulated trade protection measures and product policies in order to protect the interests and markets of their domestic enterprises, and require the relevant documents of China ' s exported goods to be certified by their embassy in China. -Manage customs clearance procedures for importing the country. Commonly found in Argentina and Egypt, the country clearly stipulates that all goods exported to the country by our country must be issued with a general certificate of origin, which will be stamped on the back of the certificate/book after verification by the embassy in China. /Book to confirm, the goods can be cleared smoothly. This practice of stamping and certifying embassies in China on valid documents is called "embassy certification"!
