概述:简称领事馆认证(LEGALIZATION BY EMBASSY OR CONSULATE),又称 "外交认证。是指一国外交、领事机构及其授权机构在公证文书或其他证明文书上,确认公证机构、相应机\*关或者认证机构的较后一个签字或者印章属实的活动。

哥伦比亚使馆通告,哥伦比亚驻沪总领馆现已开办领事认证业务。即日起,凡是江浙皖沪闽赣六省出具的送往该国的文件,均需送驻沪总领馆办-理认证,北京大使馆不再受理。望广大企业遵照执行。

## 领事认证相关注意事项

- 1. 由于办-理领事认证的时间相对较长,有需求的企业一定要尽量提早前来办-理,以争取工作上的主动。
- 2.哥伦比亚使馆要求授权书必须和营业执照一起认证。

3.菲律宾、泰国、委内瑞拉、土耳其、古巴使馆要求所有文件要一式两份,其中一份供使馆留底。如: 送办土耳其country的文件,在份数栏内应填"2"份,申办公司收到为"1"份,另1份由土耳其使馆留底 保存。

4. 巴基斯坦、黎巴嫩、印度、新加坡、卡塔尔使馆要求提供英文的目的使用说明。

Overview: Referred to as LEGALIZATION BY EMBASSY OR CONSULATE, also known as "diplomatic certification. It refers to a country's diplomatic, consular agency and its authorized agencies in the notarization document or other certification documents, confirming the notary agency, the corresponding agency \* or certification The organization 's last signature or seal is true.

Colombian Consulate General in Shanghai Launches Consular Authentication Service

The Colombian Embassy has announced that the Colombian Consulate General in Shanghai has now started consular certification services. From now on, all documents issued by the six provinces of Jiangsu, Zhejiang, Anhui, Shanghai, Fujian and Jiangxi must be sent to the Consulate General in Shanghai for certification, and the Beijing Embassy will no longer accept them. Hope that the majority of enterprises will comply with the implementation.

## Precautions related to consular certification

- 1. Since the consular certification process takes a relatively long time, companies in need must do so as early as possible in order to gain work initiative.
- 2. The Colombian Embassy requires the authorization letter to be authenticated together with the business license.
- 3. The embassies of the Philippines, Thailand, Venezuela, Turkey, and Cuba require all documents to be in duplicate, one of which shall be kept by the embassy. For example, for documents sent to the Turkish country, "2" should be filled in the number of copies column. The applicant company received "1", and the other one should be kept by the Turkish embassy.
- 4. The embassies of Pakistan, Lebanon, India, Singapore, and Qatar require instructions for use in English.
