可申办大使馆认证的文件:

- 1、经由贸促会或商检局(法检产品由商检局认证)认证 的通关结汇用的商业文件,如原产地证、商业CI、价格单、装箱单、检验证(健康证、分析证、无放射证等)、品质证/书、提单、各类运输证明、屠宰证/书等。
- 2、不属于上述1的其他文件,如商业合同、协议书、委托 代理证/书、授权书、营业执照、公司章程、银行资本证明以及业 务证明等(须经中国贸促会做成证明书,然后交外交部和驻华 使馆办-理领事认证)。

外交部领事司和使领馆认证

对申请单位提交代理的单据文件审核后,对于可以办-理领事认证的单据(如产地证)和官/方机构、公证部门出具的文件(例如商检局出具的商检证、动植物检疫局出具的动植物检疫证明等),可按要求直接送外交部领事司进行认证。对拟办-理的领事认证,属于贸促会认证范围的单据文件,如:INV、提单、屠宰证、商检公司出具的商检证、保险公司出具保险单等,先由贸促会直接加盖单据证明专用章予以认证,然后送外交部领事司认证。对于需制作国际商事证明书的,先由总会出具国际商事证明书,再送

外交部领事司。

Ministry of Foreign Affairs Department of Consular Affairs and Embassies and Consulates Certification

After reviewing the documents and documents submitted by the agency, the documents that can be certified by the consulate (such as the certificate of origin) and the documents issued by the official/party agency and the notary department (such as the commodity inspection certificate issued by the Commodity Inspection Bureau, the Animal and Plant Quarantine Bureau) The animal and plant quarantine certificate, etc.) can be directly sent to the Consular Department of the Ministry of Foreign Affairs for certification as required. For the consular certification to be handled, the documents and documents that fall within the scope of CCPIT certification, such as: INV, bill of lading, slaughter certificate, commodity inspection certificate issued by the commodity inspection company, insurance policy issued by the insurance company, etc., the CCPIT directly affixes the special seal for document certification. Be certified and then sent to the Department of Consular Affairs of the Ministry of Foreign Affairs for certification. For those who need to make an international commercial certificate, the general association first issues the international commercial certificate and then sends it to the Department of Consular Affairs of the Ministry of Foreign Affairs.
