哪些使馆要求所有认证的商业文件须提交一式两（多）份？

菲律宾、泰国、委内瑞拉、土耳其、古巴等country驻华使馆规定，对申办领事认证的文书需要留存归档，且存档的文书也要经过我国外交部领事司办-理领事认证。所以向上述外国驻华使馆申办领事认证时，应按要求一式两（多）份的原件，办-理领事认证。

哪些文件属于贸促会代理领事认证的业务范畴？

- （1）关结汇的各类商业单证，如：原产地证、商业INV、装箱单、提单、商检证、屠宰证、船证明、保险单等；
- （2）用于涉外商贸活动的各类证明文件，如：合同、协议、委托书、报关单、授权书、代理协议、营业执照、资信证明、投标文件等；
- （3）其它与涉外商贸活动相关需办-理领事认证的文件。

因使馆认证的时间一般较长，为了不影响国外客人清关，尽快安排资料作。在加签问题上拿不准主意时

, 要多与客人沟通, 因为客人比我们更熟悉他们本国的规定。

Which documents belong to the business scope of CCPIT agency consular certification?

(1) Various commercial documents related to foreign exchange settlement, such as: certificate of origin, commercial INV, packing list, bill of lading, commodity inspection certificate, slaughter certificate, ship certificate, insurance policy, etc.;

(2) Various supporting documents used for foreign-related business activities, such as contracts, agreements, power of attorneys, customs declarations, authorization letters, agency agreements, business licenses, credit certificates, bidding documents, etc.;

(3) Other documents related to foreign-related business activities that need to be certified by the consulate.

Since the embassy certification usually takes a long time, in order not to affect the customs clearance of foreign guests, we should arrange the documentation as soon as possible. When you are not sure about the endorsement, you should communicate more with the guests, because the guests are more familiar with the regulations of their country than we are.

由公证处出具的哪些文书可递交贸促会申请代理领事认证?

由公证处出具的商事类公证/书可以向贸促会申请代理领事认证, 其他民事类公证/书不予受理。

已送交使(领)馆的文件可否撤销认证申请?

文件须更改请及时和贸促会联系, 并提交撤单申请, 已进入使(领)馆的文件不可以撤销。
