同一货物的票据一正三副,是否都需要认证?

同一货物的票据的副本是否需要办-理领事馆认证,是由文书使用国决定的。如文书使用国要求对有关票据的副本办-理领事馆认证,则应按对方的要求办-理。在办-理领事馆认证前,有关票据的副本上也应加盖出证机*关的印章。

Scope of consulate certification

Its scope mainly includes:

- (1) General certificate of origin issued by the CCPIT system;
- (2) Foreign-related commercial documents certified by the CCPIT visa agency. Common ones are: commercial INV, packing list, price list, shipping company certificate, bill of lading, packing list, insurance policy, etc.;
- (3) According to the requirements of the importing country or importer, other relevant documents and documents certified by the consulate are required.

In actual business, the common documents that need to be certified by the consulate are the certificate of origin and commercial INV.

For commercial documents (such as the certificate of origin) to be certified by the consulate, it is usually specified in the letter of credit as follows: "THE CERTIFICATE OF ORIGIN SHOULD BE LEGALIZED BY EMBASSY OR CONSULATE" (The certificate of origin issued by the China Council for the Promotion of International Trade must be issued by the consulate of a certain country Certification).

领事馆认证的范围

其范围主要有:

- (1) 贸促会系统所签发的一般原产地证;
- (2)由贸促会签证机构认证的涉外商业单据文件。常见的有:商业INV、箱单、价格单、船公司证明、 提单、装箱单、保险单等;
- (3)根据进口国或进口商的要求,需要办-理领事馆认证的其它有关单据文件。

在实际业务中,需要办-理领事馆认证的单据文件为常见的是原产地证和商业INV。

对商业单据文件(如原产地证)予以领事馆认证,通常在信用证中作如下规定:" THE CERTIFICATE OF ORIGIN SHOULD BE LEGALIZED BY EMBASSY OR CONSULATE"(中国贸促会出具的原产地证明,必须由某国领事馆予以认证)。
